A MESSAGE FROM OUR CHAIRMAN

My first year as Chairman of the San Angelo Health Foundation included awarding \$4.3 million in grants, awarding over \$63 million since inception and navigating the pandemic. The Foundation was formed in 1995 with a corpus of \$44 million and to date we have awarded 846 grants! The Foundation's volunteer Board of Trustees strive to fulfill the Foundation's mission which is "to enhance the lives of the people in the San Angelo area". Soon we will reach another milestone of granting \$65 million in funding!

In 2021 we partnered with 31 organizations and funded 44 worthy projects. These projects address basic needs, health and wellness, disease and injury prevention, early childhood development, our aging population, and education. The Texas Ramp Project uses volunteer labor to install wheelchair ramps to low income, disabled and homebound residents. These ramps provide the freedom for an individual to remain in their homes. The YMCA of San Angelo is renovating space to offer an expanded preschool curriculum to low-income parents. Howard College is cultivating a nonprofit leadership training program. Their program will assist in developing tomorrow's nonprofit leaders.

Partnering with 235 nonprofits since inception has allowed the Foundation to continue its mission. Grant awards have beautified parks throughout San Angelo and the Concho Valley. Collaborations with nonprofits who provide health care, mental health and rehabilitation services insure those in need have quality care available to them. Volunteer fire departments give our rural neighbors firefighting services, EMS and vehicle crash assistance. Each partnership offers services to enhance an individual's quality of life.

The pandemic changed normal ways of life for almost everyone. The Foundation decided to stay the course and remain steadfast to our partnerships with area nonprofits. In 2021 we saw area organizations create innovative ways to continue to reach their clients. For some it was providing telehealth services, or allowing employees to work remotely or creating videos and other content to engage clients. All creating a stronger community for all of our residents in the Concho Valley.

I would like to thank my fellow volunteer Trustees for the leadership and guidance which has strengthened the core of the Foundation. The Foundation continues to seek out and identify areas that will benefit all in our community and will continue to do so. For more information please visit our website.

ALCOHOL & DRUG ABUSE COUNCIL FOR THE CONCHO VALLEY

(ADACCV)

The mission of the Alcohol & Drug Abuse Council for the Concho Valley (ADACCV) is to save lives and create healthier communities. ADACCV is a private, non-profit organization that has served the Concho Valley for over 60 years providing substance use disorder treatment services and evidence-based prevention services for youth and families. In March 2020, ADACCV opened the Journey Recovery Center, an expansion of our Sara's House and Williams House treatment facilities, and launched a long-awaited detoxification

program. Although ADACCV's clients come from all walks life and socio-economic statuses, they share the common experience of pain, misery and isolation that comes from a life lived in the grips of addiction. ADACCV is very grateful for the help and support of the San Angelo Health Foundation; with that support, ADACCV has been able to serve over 5000 clients in its treatment programs in the last decade.

BALLINGER CARES, INC.

Ballinger Cares Inc. was established on December 14, 2020 after the local food and clothing pantry was forced to close down after losing their building. Being the only resource in the community of Ballinger, the long-time volunteers saw the need to revive this resource. They had a dream for their own permanent building as well as to grow and offer more services. In 2021 a building was purchased at 402 Crosson Street. They provide free food, low-cost clothing, household and kitchen items, toys, and furniture. The building also serves as the site for Meals on Wheels, Alcoholics Anonymous meetings, the Health and Wellness Coalition of Runnels County and Cornerstone Community Action Agency. This is an all-volunteer organization living up to their motto, "Neighbors helping Neighbors."

CHILDREN'S ADVOCACY CENTER OF GREATER <u>WEST TEXAS, INC</u>

Children's Advocacy Center of Greater West Texas, Inc opened their new Stephens Campus for Children & Families in 2021. Previously operating out of four locations, this campus combines Hope House, CASA, and Family Enrichment Services programs with one consolidated location.

Their mission is to ensure every child in our community has a safe and nurturing home. They serve children from birth through 17 years old with services available 24 hours a day.

In Texas, more than 4 children die from abuse or neglect on average every week, 184 children are confirmed victims daily, and more than 7 children are maltreated every hour (texprotects.org). San Angelo Health Foundation helped provide the therapy area and additional therapists to the Hope House: LeGrand Family Facility.

Organizations meeting the above guidelines may submit grant proposals that address an identifiable current need, demand or problem in the community that is defined and documented by the applicant organization. Applications are accepted on a continuing basis.
